The Main Objectives of the Legislative Program is to improve the lives of our veterans, service members, and their families. This can be done through Advocacy. Our efforts can influence lawmakers whose decisions will affect our veterans and their families every day.

There are 6 areas of concern:

- Budget
- Health Care
- Disability Assistance and Memorial Affairs
- Education, Employment and Transition Assistance
- Military Readiness
- National Security, Foreign Affairs and POW/MIA

The focus on Disability Assistance and Memorial Affairs is to ensure veterans and their survivors have timely access to earned Benefits, Congress, VA and DOD must:

- Crack down on unaccredited claims consultants know as Claim Sharks.
- Study all toxic and environmental exposures and implement programs to ensure health care and benefits are provided to all exposed service members and veterans.
- Properly oversee and update the modernized appeals process, digital claims processing, and antiquated examination process.
- Increase Dependency and Indemnity Compensation, burial allowances and other benefits for survivors
- Improve the accuracy of disability compensation claims related to military sexual trauma
- Ensure that earned VA benefits are never unjustly reduced.

Immediate Action Needed.

According to Action Corp Weekly there are two Key VFW Priorities included in the **National Defense Authorization Act (NDAA) for Fiscal Year 2026 and must stay in the final bill.**

- **The Major Richard Star Act:** ends the offset that denies Combat-injured, medically retired veterans the full benefits they have earned.
- **The Tap Promotion Act:** improved the transition process by giving service members direct access to accredited Va claims assistance.
